### Cmdr. Charles P. Ridgway JR. USN (Ret.)

Chuck Ridgway is a retired, nuclear trained, U.S. Navy surface warfare and reserve Africa foreign area officer. A native of Eagle, Colorado, he is a graduate of Carnegie-Melon University where he earned a Bachelor of Science degree in Mechanical Engineering. He holds a Master of Public Administration from the University of Colorado at Denver and was awarded the Command and Staff Diploma from the U.S. Naval War College at Newport,RI.

Ridgway served as communications officer USS Monterey (CG 61); main propulsion division officer, USS USS Nimitz (CVN 68); and, through the personnel



exchange program to the German Navy, assistant navigator, FGS Lubeck (F 214).

From 2003 to 2022, Ridgway served as a navy reserve officer

with billets in a variety of units supporting U.S. Naval Forces Africa and U.S. Africa Command.

He deployed to Africa on numerous occasions in support of the Africa Partnership Station initiative and exercises. In 2014 he performed the assessment of the African Maritime Law Enforcement Partnership with Ghana while embarked in USNS Spearhead (JHSV-1). He also acted as U.S. Naval Forces Africa Liaison Officer embarked in Belgian Navy Ship, Godetia during her 2016 West Africa Maritime Capacity Building deployment. He retired from the Navy with the rank of Commander in June 2022.

In civilian employment Ridgway was a NATO official for ten years working in operational analysis at NATO's Joint Analysis and Lessons Learned Centre in Lisbon, Portugal. Since 2016 he has worked as a consultant for a number of international development organizations such as Africa Development Promise, Engineers Without Borders USA, Scope International, One Earth Future Foundations, Oceans Beyond Piracy and Stable Seas programs, the UN Office of Drugs and Crime's Global Maritime Crime Programme and Defense Security Cooperation Agency's Governance. He has also taught graduate-level summer courses on Monitoring & Evaluation for Regis University's International Development Practice program. In his spare time, he is a substitute teacher in the Denver Public Schools.

A fluent speaker of German, French and Portuguese, Ridgway is the winner of the Chief of Naval Operations Naval History Essay Contest, Rising History Category.

# **Association Update -**

On Thursday January 30th the USS Colorado's Commanding Officer, Commander Justin Reeves, and Chief of the Boat, Master Chief Chris Goss, held a zoom call with members of the


Submarine Association to provide an update on the boat. COLORADO arrived in Pearl Harbor in April 2024 from Groton, Connecticut and went into dry dock in June at Pearl Harbor Naval Shipyard for the routine Extended

Docking Selected Restricted Availability. They are currently in dry dock along with another Virginia class submarine, USS Illinois. The overhaul work package is proceeding smoothly and they are expected to be out of dry dock by the end of the year and complete overhaul by mid-2026. Pearl Harbor Naval Shipyard has a good record of getting their ships out on time so hopefully this schedule will hold.

The Captain described the conditions on the boat during overhaul: many spaces have temporary power, and use temporary lighting for illumination; bulkheads are covered to protect the surfaces beneath which is especially important in the crew's mess to protect the pictures of Colorado which were donated by the late artist John Fielder to decorate the boat; artifacts, plaques and other items that were donated to the boat for Commissioning have been removed for safekeeping.

During the holidays, the boat's leadership was able to grant over two weeks of leave to all the crew members so they could visit families, some of whom are still back in Connecticut. Now that all the sailors are back from leave, the boat is planning a belated holiday party in February/March.

The Captain also described submarine operations in the Pacific. He mentioned that the operational tempo is high. USS Montana recently arrived in Hawaii while USS Minnesota, which completed overhaul last summer, has changed its home port to Guam and is the first Virginia class submarine to join the four 688 class boats there currently. COLORADO is currently targeting early May for a namesake visit to our state by three to four sailors, but details have not yet been confirmed. The Association will be developing a schedule to support this visit.

We greatly appreciate the CO and COB (Chief of the Boat) taking time from their busy schedules to talk to our Association members.

The staff was impressed with the cadets' efforts on this adventure, and were fortunate to have Cy Younger, a former Sea Cadet officer, join us to plan the training and guide the cadets to the fishing camp.

Back at the Naval Reserve Center at Buckley Space Force Base, the cadets began a fourpart series on drug awareness training. This is a requirement of the program. Cadets were interested in learning and expressed that many of their schools no longer provide this training.

there will be a guaranteed trip to the base barber! Sonja Asper




